

When will the Albanian Power Exchange (ALPEX) start trading?

According to earlier announcements, the introduction of a day-ahead market and the start of trading were expected in the second half of the year. After several delays, the Albanian Power Exchange (ALPEX) will become operational at the end of March, Deputy Prime Minister and Minister of Infrastructure and Energy Belinda Balluku said.

How much money is being invested in the energy sector in Albania?

Balluku asserted that EUR 1.3 billion in private investments are underway in the energy sector in Albania. She pointed out that technical losses in the electric power system have been cut by 19.6%. The winner of the first wind power auction in the country will be known in May, the minister noted.

Why should Albania invest in energy bourses?

Speaking at an energy conference in Tirana, she added the bourse would guarantee transparency, competition and efficient use of capacities. Balluku asserted that EUR 1.3 billion in private investments are underway in the energy sector in Albania.

When did Albania adopt a new power sector law?

Based on this treaty, Albania adopted in 2015 a new Power Sector Law (no.43/2015), which transposes the EU Directive 2009/72/EC of 13 July 2009, concerning common rules for the internal market in electricity and repealing Directive 2003/54/EC.
