

What is solar financing in Australia?

These rebates make solar energy more affordable for qualifying households. In the NT, a 5kW solar PV system typically has a rebate of \$2,554, while a 10kW system gets \$5,147.

The Australian Government's no interest Green Loan program was closed to new applicants back in 2010. Although there are some solar rebates, there are currently limited government solar loans available to residential and small business customers.
