What is Bess registration?

BESS registration is a requirement for obtaining overweight permitsthat include restrictions on crossing bridges. When is BESS registration needed? What happens if I breach BESS or permit conditions?

Does NZTA maintain a list of Bess registered drivers?

NZTA maintains a list of BESS registered drivers. NZTA issues a BESS registration card when the driver has successfully completed the requirements. Drivers who wish to retain their BESS registration must complete a refresher course before the 5 year approval period expires. Note: The trial period requirements change from time to time.

How long does it take to pass Bess training NZQA unit standard 23436?

When we have checked your driving record and you are eligible for BESS registration, we will send you details of your nearest BESS assessor to book your training. You then have six months it and pass BESS training NZQA unit standard 23436. 5. If your application is declined, you can apply again in six months.

How long is Bess training & registration valid?

eligible for BESS training and full registration valid for 5 years. eligible for BESS training and provisional registration for six months. If you get no more demerit points during the provisional period, you will automatically receive full BESS registration. not eligible for BESS training and registration. 4.

How do I apply for Bess driver approval?

driver applies for BESS driver approval by filling out the required NZTA form. Every driver applying for BESS registration must complete a trafic infringement check with NZTA. Drivers must complete unit standard 23436. Drivers with a good driving history will be granted full BESS approval when they have completed unit standard 23436.

How do I become a Bess registered driver?

To be eligible for BESS registration as a driver, you must have a current driver licence class 1,2,3,4 or 5 when you apply. You must also meet the NZTA criteria for a good driving record, that is: If you are eligible for training, you must sit and pass the NZQA unit standard 23436. NZQA unit standard 23436

Companies must be registered for bridge engineering self supervision (BESS) and use BESS-registered drivers as a condition of operating a heavy motor vehicle under an overweight permit with bridge restrictions.
