Which sector produces res energy in Bosnia and Herzegovina?

Production of RES energy in Bosnia and Herzegovina is dominated by the heating and cooling sector, for which an increase from the baseline 867.2 ktoe to 1085.2 ktoe in 2020 was planned. In addition, the share of electric energy sector in production of RES energy in the planned period increases from the baseline 444.2 ktoe to 760.6 ktoe in 2020.

After launching a tender in July for a turnkey contract for a smaller facility within its Breza mining complex, Elektroprivreda BiH is now looking for a contractor for a 50 MW solar power system. The location is in the Bugojno municipality, on recultivated landfills of another mine.

Who is attracting foreign investment to Bosnia & Herzegovina?

The government agency responsible for attracting foreign investment to Bosnia and Herzegovina has successfully pitched the municipality of Grude to Norwegian renewables company Greenstat. Bosnia's Foreign Investment Promotion Agency (Fipa) said last week that the Bergen-based developer has started working on the 45 MW Petjnik solar plant.

Chinese company Norinco International plans to buy an 80% stake in Aurora Solar, a firm in Bosnia and Herzegovina that has been granted a concession to build a 125 MW solar power plant near Stolac in the Herzegovina-Neretva Canton, Capital.ba has reported.

Gracanica Solar PV Park is a 50MW solar PV power project. It is planned in Central Bosnia, Bosnia and Herzegovina. According to GlobalData, who tracks and profiles over 170,000 power plants worldwide, the project is currently at the permitting stage.
