## Can a power storage box be placed in the monitoring room

#### Should a battery room be ventilated?

According to the National Electrical Code, (NEC) the battery room should be ventilated, as required by NFPA 70 480.10 (A). "Ventilation. Provisions appropriate to the battery technology shall be made for sufficient diffusion and ventilation of gases from the battery -- to prevent the accumulation of an explosive mixture."

#### How should a storage unit be positioned?

Good air circulation around the outside of the storage unit is important. Place a storage unit in a well-ventilated room, leaving space between the unit, ceiling, and any wall. Nothing should block the cover of the motor compartment. The unit should be firm and level, with the bottom of the unit above the floor.

#### Do you need documentation for a battery room?

The employer must know, document and train the employee for the assigned task and exposed risks. It is a requirement to have all the documentation in place prior to authorized personnel entering a battery room to perform a specific work task on a battery system under normal operating conditions.

#### How is battery room compliance interpreted?

Battery room compliance can be interpreted differently depending on your battery type, amount of cells or multi-cell units in a common area, volume of electrolyte and voltage present. Although the code is specific about requirements, the local interpretation can vary depending on the end users experience or awareness.

#### Where should a storage unit be located?

Place a storage unit in a well-ventilated room, leaving space between the unit, ceiling, and any wall. Nothing should block the cover of the motor compartment. The unit should be firm and level, with the bottom of the unit above the floor. Make sure the unit door opens and closes smoothly and fits squarely against the body of the unit.

#### Do you need a barrier for a stationary battery system?

Instead,a standard barrier is recommended with the pads that contain less neutralizing absorbing compound. IFC 608.7; NPFA 52.3.8 Approved signs are required for Entrances to rooms and buildings with stationary battery systems of all technologies.
