The following retrofits are eligible for the Canada Greener Homes Grant and the Canada Greener Homes Loan. Upgrade your eligible attic,cathedral ceiling,flat roof,exterior wall,exposed floor,basement and crawl space. Perform air sealing to improve the airtightness of your home to achieve the air-change rate target.

Where can I get a solar loan in Canada?

People living in Halifax, Amherst, Bridgewater, and other municipalities, can also access one of Canada's best solar financing programs, PACE. The property assessed clean energy program lets homeowners install their solar with a \$0 down, long amortization period, low-interest loan.

How much does a solar incentive cost in Alberta?

Generally speaking,most municipalities throughout Alberta that offer a solar incentive set it around \$0.70/watt,with a maximum of \$5,000 in savings.
