

How can a Nevis IBC be incorporated?

Once the name has been reserved, the Nevis IBC can be incorporated by filing Articles of Incorporation with the Registrar of Corporations. If the incorporation documents comply with the NBCO, a certificate of incorporation and/or endorsement certificate certifying the incorporation can be issued.

Can a corporation be incorporated in Nevis?

The Nevis Business Corporation Ordinance provides for a corporation to be incorporated to conduct any lawful business. A person interested in incorporating an IBC in Nevis must first engage the services of a registered agent licensed by the Nevis Island Administration with a registered office in Nevis.

What are the benefits of using the Nevis business corporation?

The benefits of using the Nevis Business Corporation can be summarized as follows: The NBCO permits the use of shareholders, officers and directors, who may be of any nationality and who may reside anywhere. Also, a Managing Director may be appointed to guide the corporation's activities.
