What is a commissioning plan?

Commissioning is a required process in the start-up of an energy storage system. This gives the owner assurance that the system performs as specified. A Commissioning Plan prepared and followed by the project team can enable a straightforward and timely process, ensuring safe and productive operation following handoff.

Commissioning is a gated series of steps in the project implementation process that demonstrates, measures, or records a spectrum of technical performance and system behaviors. What are the test procedures for energy storage systems?
