Why did the US impose import duties on solar panels?

Why are US solar panel imports so high?

US solar panel imports reached their highest level ever in the third quarter of 2023,reflecting the surging market's deepening dependence on Asian supply chainseven as a fleet of new domestic factories emerges.

Where do solar panels come from?

Most solar panels installed in the United States are made overseas, and some 80% of imports come from the four nations targeted in the Commerce Department probe. The Biden administration this year raised the alarm over China's massive investment in factory capacity for clean energy goods.

Why are US tariffs on solar panels coming to Southeast Asia?

Nov 29 (Reuters) - U.S. trade officials announced on Friday a new round of tariffs on solar panel imports from four Southeast Asian nations after American manufacturers complained that companies there are flooding the market with unfairly cheap goods.

Where did solar imports come from in the third quarter?

Just over 78% of imports in the third quarter came from four Southeast Asian countries: Vietnam, Thailand, Malaysia and Cambodia. India accounted for 8.7%. Based on containers, the single-largest shipper in the quarter was a Vietnam-based subsidiary of US thin-film PV producer First Solar Inc.

What will the US government do if imported solar panels exceed quota?

The Administration will closely monitor the level of imported solar cells used to manufacture panels in the U.S. and will work to raise the quota by 7.5-gigawattsif imports approach the current quota level, to ensure domestic module manufacturing continues to grow while manufacturers scale production throughout the supply chain.
