Does trade protection affect global PV trade patterns?

The global PV trade patterns Empirical studies predict that a shock that hits anywhere would be transmitted throughout the trade network (Prusa,1997). Accordingly, the impact of trade protection on Chinese PV export will inevitably transmit to global PV trade patterns.

How much of China's PV exports deflect to new markets?

The results show that about 20 billion dollars of PV products,account for 22.66% of China's overall PV export, deflected to new markets from 2012 to 2016. Both local and destination spillovers are conducive for Chinese PV exports to deflect to countries without extra tariffs.

Which countries export PV products?

China's PV products increasingly export to the US, Germany, Italy, and Australia before 2011. After 2011, the exports to the US and the EU experienced a negative growth while exports to Japan, India and Brazil increased dramatically, indicating the negative impact of trade barriers.

How can Green trade barriers help China's photovoltaic industry?

Policymakers should consider exchange rate levels, language environments, CO2 emissions and renewable energy consumption when formulating green trade barrier standards to better support the competitiveness and export growth of Chinese photovoltaic products in the international market.

Does trade protectionism affect China's solar PV exports?

Zhu et al. (2021) examined the impact of both internal and external forces on China's solar PV export during 2007-2016, and found that trade protectionism and some non-tariff barriers inhibit China's PV exports.

Do Green trade barriers affect photovoltaic exports?

Specifically, green trade barriers have a positive impacton the export of photovoltaic products in countries with higher exchange rates and different official languages, whereas their impact is insignificant or negative in countries with lower exchange rates and the same official language.
