Does French Guiana have a pluriannual energy program?

As Guadeloupe, Martinique, Reunion and Mayotte, French Guiana has its own pluriannual energy programming. With an objective of energy autonomy set on the 2030 horizon, they have to accelerate the large-scale clean energy deployment to improve energy access.

#### How will bioenergy help French Guiana?

Government officials in French Guiana are pushing the proposal as a means to reduce their dependency on fossil fuels for energy. Local officials also hope bioenergy will create much-needed new jobsin the territory which has 26% unemployment.

#### How much CO2 does French Guiana produce?

In 2011,CO2 emissions in French Guiana relative to the electricity production was estimated at 360 GCO2/kWhwhich was four times higher than Metropolitan France (Figure 3).
