What is Heard Island & McDonald Islands Marine Reserve?

Heard Island and McDonald Islands Marine Reserve means the areas declared as a Commonwealth reserveby that name under the EPBC Act on 16 October 2002 and amended on 28 March 2014. HIMI means Heard Island and McDonald Islands. means the part of the Australian Government agency with responsibility for administration of the HIMI Territory.

What is the Heard Island & McDonald Islands Marine Reserve management plan?

This management plan may be cited as the Heard Island and McDonald Islands Marine Reserve Management Plan. This management plan will enter operation following approval by the Minister under s.370 of the EPBC Act on the day after it is registered under the Legislative Instruments Act 2003 or on a later date specified in the Minister's approval.

Who administers the Heard Island & McDonald Islands Act?

Administration of the Territory is the responsibility of the Australian Government department administers the Heard Island and McDonald Islands Act 1953. This responsibility has historically been undertaken by the Australian Antarctic Division.

Why are Heard Island and McDonald Islands isolated?

Where is the Heard Island & McDonald Islands EEZ located?

When was the Heard Island and McDonald Islands reserve proclaimed?
