The Cabinet of Iran (Persian: ???????????nomanized: Heyatedovlat-e Iran) is a formal body composed of government officials, ministers, chosen and led by the President of Iran. Its composition must be approved by a vote in parliament.

13-a) The energy label is considered part of the marking of goods and must be installed on the goods (the energy label must be based on the relevant national standard and without the logo of Iran National Standards Organization).

Who has the power to dismiss a cabinet member in Iran?

The Supreme Leader of Iran Ali Khameneihas the power to dismiss cabinet members like ministers, vice presidents and presidents at any time, regardless of parliamentary decisions. (citation needed) From 1699 until 1907 the Iranian cabinet was led by Premiers who were appointed by the Shah of Iran.

Can a president appoint a cabinet member in Iran?

Its composition must be approved by a vote in parliament. According to the Constitution of the Islamic Republic of Iran, a president may dismiss members of the cabinet, but must do so in writing, and new appointees must again be approved by parliament.

How many ministers have been dismissed from Iran's cabinet?

From August 2009 to February 2013, nineministers in the cabinet were dismissed by the Majlis, the last of who was labor minister, Reza Sheykholeslam at the beginning of February 2013. Hassan Rouhani was elected as President of Iran in 2013 presidential election and took office on 3 August 2013.
