

What is the economic partnership between Ivory Coast and the UK?

The Ivory Coast and the UK signed an economic partnership agreement in 2020, which allows to maintain continuity in the trade relationship between both countries following the exit of the UK from the European Union. What are interim EPAs with Ivory Coast and Ghana?

The European Commission initialled interim EPAs with Ivory Coast and Ghana in December 2007. These agreements were put in place to prevent disruption to their exports to the EU after the trade provisions of the Cotonou Agreement expired at the end of that month and provide additional time to negotiate a full regional EPA.

Who owns the Ivory Coast electricity company?

With 4 995 employees in 2022 and 54.02% owned by Eranove, the Ivory Coast Electricity Company (CIE) is a private provider that has been linked to the Ivory Coast's government by a concession agreement since 1990.
