Chinese manufacturers have responded to U.S. solar tariffs by moving their massive operations to nations where they will not face duties- including Southeast Asia.

Will Obama-era solar tariffs make new solar projects more expensive?

The ruling, unveiled Friday, means that new U.S. solar projects may soon be more expensive: manufacturers whose goods run afoul of Obama-era solar tariffs will be subject to additional import duties on their products.

In addition, the Japanese government said that it will hold four auctions for solar projects exceeding 250 kW in size in 2024. What are Japan's feed-in tariffs?

Japan's feed-in tariffs (FITs) for this year will range from JPY 9.5 (\$0.06)/kWh to JPY 16/kWh,depending on system size. The Japanese government also says it will hold four more auctions for solar projects above 250 kW this year.

Will the solar industry be liable for trade abuses in 2024?
