Who owns Axion Energy?

Who has power in Kyrgyzstan?

Executive power in Kyrgyzstan lies with the government, its subordinate ministries, state committees, administrative agencies and local administrations. In the energy sector, the government: Grants and transfers property rights, and rights for use of water, minerals and other energy resources.

Could Kyrgyzstan attract massive energy and transport investments?

Given the right socio-political and policy conditions, the country could attract massivecross regional energy and transport investments (World Bank, 2019). Kyrgyzstan's gross domestic product (GDP) per capita in 2020 was USD 1 176 (World Bank, 2021).

Who owns PAEG & Axion?

PAEG will be owned equally by BP and Bridas Corporation, itself a 50:50 joint venture of Bridas Energy Holdings of Argentina and CNOOC Limited of China. PAE is currently owned 60% by BP and 40% by Bridas, while Axion is wholly-owned by Bridas. There will be no payments for the equity exchange.
