Will EPC contracts provide for the handover of a solar facility?

EPC Contracts will notprovide for the handover of the solar facility to the Project Company, and the PPA will not become effective until all commissioning and reliability trialling has been successfully completed.

Do solar projects need an EPC contract?

In our experience,most utility-scale solar projects use an EPC Contract. An operation and maintenance agreement: This is usually a medium- to long-term Operating and Maintenance Agreement (O&M Agreement) with an Operator. The term of the O&M Agreement will vary from project to project.

Can large scale solar PV be commercialised without government funding?

However, it is now widely recognised that large scale solar PV has been commercialised and is viable without Government funding, eg. the 300MW Bungala Solar Project which was co-developed by Reach Solar energy and PwC with no Government funding (except the RET).

Who is responsible for building a solar photovoltaic power plant?

The vast majority of large solar photovoltaic power plants are being built using a fully protected EPC (engineering, procurement and construction) contract. In this case, the companyresponsible for the construction takes on maximum responsibility.
