Who determines the final content of a solar PV solicitation?

Agency contract officers, attorneys, and engineers are responsible for determining the final content of any solicitation. Updated to the regulations, codes, and standards applicable to solar PV are changing frequently; it is the responsibility of agency managers to determine which guidelines (and which versions) apply. Figure 1.

Are solar photovoltaic systems a good investment?

For sites with time-of-use (TOU) and/or demand rates, solar PV systems are to be designed to offset the greatest amount of electricity in higher cost-rate periods and achieve the greatest annual dollar savings. Feasibility evaluations to determine the potential size of solar photovoltaic systems have not been completed.

What types of electrical plans are included in a PV system?

Electrical Plans, including single-line electrical diagrams showing utility interconnection and all devices comprising the PV system, including, but not limited to: PV arrays, combiner boxes, circuit breakers, disconnect switches, inverters, meters, timers, control devices, and other equipment comprising the complete system.

What happens if a bid is rejected?

The upset contractor could file a bid protest with the Government Accountability Office (GAO) or with the U.S. Court of Federal Claims. This process can significantly delay the performance date. If a bid is rejected, it is essential to contact the contracting officer and ask questions about why the proposal was rejected.

What happens if a solar contractor is awarded a contract?

Upon an award,the solar contractor is bound to execute the contract and begin performance. If another contractor that supplied a proposal thinks that it had the best value proposal,the contractor can question the government's evaluation process.
