Are "free" solar panels a scam?

However, it's important to note that "free" solar panels are not always a scam, but they do require careful consideration. These "free" solar panels are typically offered through solar panel leases or power purchase agreements (PPAs), which allow individuals to install solar panels without the high expense.

How do I present a solar panel installation proposal?
