What types of contracts do Solar Contractors need?

Solar contractors should also be aware that federal contracts can be further categorized by the type of delivery -- indefinite delivery contracts, definite quantity contracts, requirement contracts and single-task order contracts -- and type of price -- fixed-price contracts, cost-reimbursement contracts and incentive-type contracts.

What is the difference between a solar PPA and a lease?

Similar to a solar PPA, a solar lease scenario also involves a third-party owner and can often be structured with no upfront cost. The primary difference between a PPA and a lease is that rather than pay per kWh used as you would in a solar PPA, you'll pay a fixed rate over the lifetime of the contract (typically 7-25 years).

What is a solar service provider (SPPA)?

With this business model, the host customer buys the services produced by the PV system rather than the PV system itself. This framework is referred to as the " solar services" model, and the developers who offer SPPAs are known as solar services providers.
