Where is Stage 1 Muara Laboh geothermal power generation located?

What is Muara Laboh geothermal power plant?

Muara Laboh geothermal power plant is a 220MW greenfield project coming up in Muara Laboh, Solok Selatan Regency, West Sumatra Province of Indonesia. PT Supreme Energy Muara Laboh (SEML) proposes to develop the project as a grid-connected power plant to supply low-emission power to the Sumatera grid.

How much does Supreme Energy Invest in Muara Laboh PLTP?

Supreme Energy began a preliminary study in the Muara Laboh PLTP development project in 2008. Then, the Power Purchase Agreement (PPA) was signed in 2012, and continued with exploration activities. The total investment for this phase-1 development reaches US \$580 million.

What is Muara Laboh PLTP?

The operation of the Muara Laboh PLTP further adds to the reliability of electricity supply in the West Sumatra region. Electricity from this PLTP can power up to 340 thousand households. Muara Laboh PLTP is managed by PT Supreme Energy Muara Laboh (SEML), a joint venture company PT Supreme Energy, ENGIE, and Sumitomo Corp. Source: Panas Bumi News

How long did it take supreme energy to tender Muara Laboh?

In 2010 Muara Laboh was tendered. So it took Supreme Energy two years to wait for the tender since submitting the study results, "he explained. According to Supramu, the main obstacle in geothermal development in Indonesia is tariffs. According to him, it took Supreme Energy four years to reach an agreement on the tariff for Muara Laboh and PLN.
