## Who is big Energia holdings?

BIG Energia Holdings won an international tender for the construction of a combined wind and solar project in Bileca in Bosnia and Herzegovina and entered into a long-term lease of property in Romania for the construction of a solar power plant.

How much will Big Energia pay for the Wind Project?

In the initial stage of the acquisition, BIG Energia will pay EUR 9 millionfor the shares of a Romanian company which owns rights in the wind project and for the project development. The amount will be paid in accordance with the pace of the project development until the approval of construction permits.

Will big Energia develop a wind farm in Romania?

Hungary-registered BIG Energia Holdings,part of the Israeli group BIG Shopping Centers (the owner of AFI shopping malls in Romania,among others),have all the permits to develop a 96.9MW wind farm in eastern Romaniain Braila county,Ziarul Financiar reported. The investment is estimated at EUR 78-80 mln.

The Company is ultimately fully owned by BIG Energia Holdings kft established in Hungary, which is in turn is owned by BIG Shopping Centers ltd and MEGA OR ltd., both are Israeli companies operating as owners and developers of shopping malls and logistics properties, and both are listed on the Tel Aviv stock exchange.
