This 6 MW power plant can produce up to 2% of the Seychelles' power and is located on Mahé Island. It is expected that the wind farm will replace 1.6 million litres of diesel fuel annually.

### When will electricity be produced in the Seychelles?

Electricity production is expected to be highly seasonal with the majority of energy produced in the months of June to Septemberwhen wind strength and wind probability are highest on the island of Mahe.
