How much does electricity cost in Puerto Rico?

The base electricity cost per kilowatt-hour in Puerto Rico for a residential customer is \$0.04944for the first 425 kWh consumed, and \$0.05564 per kWh after 425 kWh of consumption, with base fee of \$4 which is independent of consumption. Where the majority of the cost in energy comes is in the fuel charge and energy purchase clauses.

Does Luma energy have a power grid in Puerto Rico?

The contract under which LUMA Energy operates the power grid in Puerto Ricowas signed after a bid in 2020. In the bid, five different companies participated and only four submitted business proposals. The \$1,500M contract is set to last for 15 years and can be renewed if both parties agree.

Will Luma energy restore power to Puerto Rico's 88,000 customers?

In a lengthy and contentious legislative hearing in the Puerto Rico House of Representatives on Wednesday, Luma Energy President Wayne Stensby and other company officials answered questions from local legislators worried about the company's ability to restore electricity to more than 88,000 power customers who remain in the dark.
