Which countries impose anti-dumping and countervailing duties on aluminum extrusions?

The ITC issued a rare negative determination regarding anti-dumping and countervailing duties on imports of aluminum extrusions from China, Colombia, Ecuador, India, Indonesia, Italy, Malaysia, Mexico, South Korea, Taiwan, Thailand, Turkey, United Arab Emirates, and Vietnam.

Are solar panel racking rails affected by antidumping and countervailing duties?

As a result, Commerce has imposed antidumping duties at rates ranging from 2.02% up to 376.85%, and countervailing duties at rates ranging from 1.44% up to 168.81%. Commerce has included extruded solar panel racking rails within the group of products affected by these impending import duties.
