Does fit offer quota for solar PV?

FiT for solar PV was introduced at the end of 2011 and by 2017,FiT does not offer new allocation of quota for solar PV anymore. The FiT scheme currently services the monthly payments of solar PV which was released for quota from 2011 to 2017. Under the FiT scheme, the PPA tenure is 21 years.

Are floating solar power plants included in the 2GW quota?

There will also be an introduction of a special category, dedicated to floating solar power plants with a quota of 500MW although it is still unclearwhether the floating solar quota will be separate or included in the overall 2GW quota.

What is the IEA photovoltaic power systems programme?

The IEA Photovoltaic Power Systems Programme (IEA PVPS) is one of the TCP's within the IEA and was established in 1993. The mission of the programme is to "enhance the international collaborative efforts which facilitate the role of photovoltaic solar energy as a cornerstone in the transition to sustainable energy systems."

When will the Solaris rebate quotas be distributed?

*Subject to the terms and conditions of the SolaRIS programme. Rebate allocation is on a first come, first served basis from 1 April until 31 December 2024 and successfully commission their solar PV system installations by 31 March 2025, or until all SolaRIS rebate quotas are fully distributed, which ever come first.
