## Solar power generation cooperation and franchise contract

What is a solar power purchase agreement (SPPA)?

A Solar Power Purchase Agreement (SPPA) is a financial arrangement which a third-party developer owns, operates, and maintains the photovoltaic (PV) system, and a host customer agrees to site the system on its property and purchases the system's electric output from the solar services provider for a predetermined period.

#### Do solar projects need an EPC contract?

In our experience, most utility-scale solar projects use an EPC Contract. An operation and maintenance agreement: This is usually a medium- to long-term Operating and Maintenance Agreement (O&M Agreement) with an Operator. The term of the O&M Agreement will vary from project to project.

#### What is open solar contracts?

As a response, the International Renewable Energy Agency (IRENA) and Terawatt Initiative (TWI) undertook a joint efort to simplify and streamline the contractual framework for solar power. The Open Solar Contracts initiative aims to unlock greater investments globally.

#### Will EPC contracts provide for the handover of a solar facility?

EPC Contracts will notprovide for the handover of the solar facility to the Project Company, and the PPA will not become effective until all commissioning and reliability trialling has been successfully completed.

#### How are open solar contracts drafted?

The Open Solar Contracts are drafted on the assumption that the buyer is a national or local government-owned or government-controlled utility (but this also can be extended to private buyers authorised by the government). Furthermore, the oftake is assumed to be guaranteed in some form.

#### What is a solar service provider (SPPA)?

With this business model, the host customer buys the services produced by the PV system rather than the PV system itself. This framework is referred to as the " solar services" model, and the developers who offer SPPAs are known as solar services providers.
