Does a solar rebate affect tax credit?

If the solar rebate is from a government agency,the 30% federal tax credit remains unaffected. If the rebate comes from a utility company or other non-government sources,the 30% tax credit is calculated based on the net system cost after the rebate.

How does a solar PV rebate work?

For example, if your solar PV system was installed in 2022, installation costs totaled \$18,000, and your state government gave you a one-time rebate of \$1,000 for installing the system, your federal tax credit would be calculated as follows: \$18,000 * 0.30 = \$5,400

Where can I find solar rebates & tax credits?

You can use the Database of State Incentives for Renewables &Efficiency(DSIRE) to find rebates and state tax credits are available in your ZIP code. Some states have a statewide tax credit that you can apply in addition to the federal solar tax credit.

How much is a solar tax credit worth?

Even though it's commonly known as the solar tax credit, the Residential Clean Energy Credit also applies to battery storage, wind, geothermal heat pump, and fuel cell expenditures. So if your all-in solar cost is \$25,000, your federal solar tax credit would be worth \$7,500.
