Massachusetts law Chapter 40A states that "no zoning ordinanceor by-law shall prohibit or unreasonably regulate the installation of solar energy systems or the building of structures that facilitate the collection of solar energy, except where necessary to protect the public health, safety or welfare."

What are Washington DC's Solar access laws?

Washington DC's solar access laws are found in the District of Columbia Code § 8-1774.51, which limits the "authority of homeowners associations, condominium owners associations, and cooperative housing associations to prohibit the installation and use of solar energy collection devices.
