Can you get a solar loan in Canada?

Canada Greener Homes Loan - As part of the Greener Homes Initiative, eligible homeowners can also receive a 10-year interest free loan of \$5,000 and up to \$40,000 to help finance their solar system. There are currently 7 solar energy incentives available in Alberta. This includes 5 rebates and 2 financing programs.

Does Canada offer solar incentives?

Canada's federal government provides three solar incentives: two of which are exclusively commercial and one which is residential. It also offers investment tax credits in a variety of clean energy sectors. a. The Greener Homes Rebate

Does Canada have a solar rebate program?

Canada's most petite province boasts three solar incentives, including the Solar Electric Rebate Program, which offers substantial rebates to make solar energy more accessible for homeowners, businesses, and farmers. For residential installations, the program offers \$1,000 per kW installed, up to 40% of installed costs or \$10,000.

Where can I apply for the Canada greener Homes Grant?

The Canada Greener Homes Grant is delivered in collaboration with the provinces of Nova Scotia, Ontario, and Quebec. If you live in one of these provinces and have an active application, please contact your provincial program for more information.

How many solar energy financing programs are available in Saskatchewan?

There is currently 1 solar energy financing programavailable in Saskatchewan. Home Energy Loan Program (HELP) - The City of Saskatoon currently offers a "PACE" loan of up to \$60,000 over flexible repayment terms of up to 20 years.

What solar energy incentives are available in New Brunswick?

There are currently 2 solar energy incentives available in New Brunswick. This includes 1 rebate and 1 financing program. Total Home Energy Savings Program- NB Power currently offers a \$0.20 per watt rebate on solar photovoltaic systems (only available through the Total Home Energy Savings Program).

As a key part of Canada's forthcoming Canada Green Buildings Strategy, which will focus on energy and housing affordability, this next phase will offer supports that are more accessible to Canadian households with low to median incomes, so that energy cost-savings are available to those who need them most.
