

## State Grid made five statements on Weibo

Who owns State Grid?

As of March 2024, State Grid is the world's third largest company overall by revenue, behind Walmart and Amazon. In 2023 it was reported as having 1.3 million employees, 1.1 billion customers and revenue equivalent to US\$546 billion. It is overseen by the State-owned Assets Supervision and Administration Commission of the State Council.

Will a power limit collapse a regional power grid?

The State Grid was cited by the Beijing News on Sunday as saying that the power limit was first exercised on non-residential usage, but there were still gaps that may cause the collapse of the regional power grid, adding to the residential power shortage. It said the recovery of residential power would be a priority.

How many energy projects has the State Grid built?

Up to now, the State Grid has built 33 ultra-high-voltage transmission and transformation projects, constructed the world's largest new energy cloud platform that connected over 4.4 million new energy stations.

When was the State Grid Corporation of China founded?

The State Grid Corporation of China was founded on December 29, 2002, when the restructuring divided the former State Power Corporation of China into two grid companies, five generation groups and four accessorial business companies.

Why is the national grid strengthening the unified dispatch of power network?

The National Grid said that it is strengthening the unified dispatch of the entire power network, including exploiting the power transmission potential of inter-regional and inter-provincial channels.

What percentage of China's power grid is SGCC?

SGCC accounts for 80% of the Chinese grid, with China Southern Power Grid accounting for the other 20%. : 40 At its creation, SGCC company had a generation capacity of 6.47 gigawatts.
