In Tajikistan's neighbouring countries, the various national ministries for energy, economy and trade as well as the entities involved with generation, transmission and distribution of electricity as trading partners are relevant stakeholders in establishing efficient cross-border electricity trading.

According to the Agency of Hydrometeorology of Tajikistan, the duration of sunshine in the country is 2100-3166 hours per year, and the number of sunny days per year ranges from 260 to 300. This provides great opportunities for the use of solar energy as an alternative, especially in mountainous regions where there are no power lines.

Energy is a large contributor to CO<sub>2</sub> - the burning of fossil fuels accounts for around three-quarters of global greenhouse gas emissions. So, reducing energy consumption can inevitably help to reduce emissions.

The Albanian government said it has approved the construction of a 100 MW PV plant near the southwestern town of Fier by local renewable energy producer Sunny Side Energy. The facility is expected to be operational within 36 months, with a 49-year operating term, the government said on Wednesday.

The nation's potential for both solar and wind power is high. The Agency of Hydrometeorology of Tajikistan states that, given Tajikistan's geographical location, it is in a "golden belt" for sunshine, according to CABAR . Up to 3,166 hours of sunlight and 300 clear sunny days make the nation ideal for solar energy.
