Who owns Sao Tome & Principe?

Petrobrashas acquired stakes in three blocks offshore Sao Tome & Principe,under a deal with Shell. Under the agreement,the Brazilian company has acquired 45% stakes in Blocks 10 and 13,and 25% in Block 11. Shell is the operator of the three blocks with a 40% stake,while ANP-STP has 15% stakes. Galp has a 20% interest in Block 11.

Is shell acquiring Kosmos Energy in Sao Tome?

Shell entered Sao Tome in 2019,on Blocks 6 and 11. It then acquired Kosmos Energy's local interests,giving it entry into Blocks 10 and 13,in 2020. ANP-STP announced a plan to bring in a partner on its Block 4,in October this year. Farmout Angel reports that the agency is offering 85% to partners in the block,while also offering Block 2.

Does Sao Tome and Principe have a right to education?

The Human Rights Measurement Initiative (HRMI) finds that Sao Tome and Principe is fulfilling only 83.8% of its expected commitments to the right to educationbased on the country's level of income. HRMI breaks down the right to education by looking at the rights to both primary education and secondary education.
