The project is scheduled for full construction completion and commercial operation by the end of 2028, with an expected annual power output of 5,76 GKWh. The ...

The reasons seems to be the lack of interest by EDF, which had decided to reduce its stake in the plant to a symbolic level. It also had abandoned a geothermal project in Dominica, which would have provided electricity to Guadeloupe and Martinique.
