How can Tonga transform its energy sector?

The Government of Tonga has formulated targets to transform its energy sector by achieving a 50 percent share of renewables in the country's energy generation mix by 2020 and 70 percent by 2030. However, achieving these targets require catalytic investments to transform the country's energy infrastructure.

How will Tonga's New Energy Park work?

The project will be delivered in two phases-- the first will begin later this year and will be a two-megawatt park, which will generate enough power for close to 3,000 homes. Once the entire 10-megawatt project is complete, it is expected to provide half of Tonga's energy and cut emissions by 20 per cent.
