## VAT policy for solar power generation

Are solar panels subject to VAT?

This guidance sets out the VAT treatment of the supply and installation of solar panels. The supply of solar panels is subject to the standard rate of VAT. However, the reduced rate or zero rate may apply when solar panels are supplied and installed as part of a supply and install contract.

What is the VAT rate on solar panels?

Recent changes in EU VAT (Value Added Tax) policy have provided EU Member States with greater flexibility over VAT rates on solar panels. Several countries in Europe have a 0% VAT rate on solar panels (subject to certain conditions depending on the country), while other countries VAT rates vary from just above 0% to 25%.

What is the VAT rate on solar panels in Belgium?

The rate of VAT on solar panels in Belgium is mostly charged at the standard VAT rate at 21%, however there is scope for a 6% VAT rate for solar panels subject to certain conditions.

Does Ireland pay VAT on solar panels?

As a result of this Directive, Ireland has opted to apply a zero percentVAT rate on all domestic solar panels, both supply and installation. There remains, however, significant variation across the Member States in both the rates of VAT being applied and the criteria used to designate the applicable VAT rate.

What is the current VAT treatment on the installation of energy-saving materials?

This briefing explains the current VAT treatment on the installation of energy-saving materials in the UK, analyses recent changes, and outlines recent developments. A zero-rate of VAT on the installation of energy-saving materials (ESMs), including solar panels, in residential accommodation, was introduced on 1 April 2022.

What is the VAT rate for solar panels in Spain?
