Vortex Energy was founded in 2014 as a platform to pursue renewable energy investments worldwide. Last September, the company sold a controlling and managing stake in a 365MW solar photovoltaic portfolio in the UK to TNB International, a subsidiary of Tenaga Nasional Berhad.
