Where is Wallis & Futuna located?

Wallis and Futuna,officially the Territory of the Wallis and Futuna Islands[A](/'w?lIs ... fu:'tu:n? /),is a French island collectivity in the South Pacific,situated between Tuvalu to the northwest,Fiji to the southwest,Tonga to the southeast,Samoa to the east,and Tokelau to the northeast. Mata Utu is its capital and largest city.

When did Wallis & Futuna become a French colony?

Wallis and Futuna was the only French colony to side with the Vichy regime during World War II until the arrival of Free French and US troops in 1942. In 1959,inhabitants of the islands voted to separate from New Caledonia and become a French overseas territory, a status it assumed in 1961.

Who settled Wallis & Futuna?

French Catholic missionarieswere the first Europeans to permanently settle Wallis and Futuna in 1837. The missionaries converted most of the population of Wallis by 1842 and of Futuna by 1846. The missionaries and newly-converted King LAVELUA of Uvea on Wallis asked France for a protectorate in 1842 following a rebellion of locals.

How did SPREP help Wallis & Futuna?

Work to build effective coordination and implementationacross the three different projects was the focus of a mission to Wallis and Futuna by SPREP in April. To help catalyse this, meetings were held with His Majesty Lavelua King of Wallis, the Vice-President of the Territorial Assembly, the Prefect and Superior Administrator of Wallis and Futuna.

Who was the first European explorer to visit Wallis & Futuna?

Dutch explorerswere the first Europeans to see the islands in 1616, followed intermittently by other Europeans, including British explorer Samuel WALLIS in 1767. French Catholic missionaries were the first Europeans to permanently settle Wallis and Futuna in 1837.

Why did Wallis & Futuna win a weed control prize?

Wallis and Futuna was awarded the prize in 2021 following success in managing invasive weeds and animals with very limited support due to travel restrictions imposed by the COVID-19 pandemic.
