What are American Solar scam calls?

American Solar scam calls are fraudulent callsin which a scammer poses as American Solar or a similarly named company. Their goal is to gain personal information by making bogus offers for free or low-cost solar energy services.

How do I know if a solar energy company is a scam?

Look out for callers that create a sense of urgency, offer unbelievable deals, or solicit personal information. Legitimate solar energy companies won't ask for private information like dates of birth, Social Security numbers, or financial details. What should I do if I receive a suspicious call about solar energy?

Are solar energy companies scamming consumers?

As solar energy has boomed over the years, some companies " have preyed on consumers by offering predatory and costly loans, " and many of them " are engaging in overly aggressive sales tactics or are outright scamming consumers, " said CNET.

Are solar business leads a scam?

At best, this is someone generating leads to sell, not actual solar businesses. At worst, they're scammerstrying to steal your identity. If you spot a scam, tell the Federal Trade Commission at ReportFraud.ftc.gov.

How do I file a complaint against a solar panel company?

Check your state's DOJ website for information on filing a lawsuit or settling a complaint in small claims court.
