Since 1975, people from Western Sahara (also known as Sahrawi) have lived as refugees in camps near Tindouf city, in southwest Algeria, an area with a harsh desert environment. Their situation is considered a protracted emergency, as there is a stalemate to negotiations, with no sign of imminent resolution.

The intensity of the hostilities over Western Sahara during the conflict"s latest round has remained fairly limited, mainly due to a military imbalance in favor of Rabat. Since the end of the cease-fire in 2020, the Polisario has been able to do little more than fire at the Moroccan sand berm in a series of hit-and-run attacks.
