Certain homeowners associations (HOAs) prohibit solar panel installations, but these are generally illegal and unenforceable. In short, HOAs cannot ban installations of any solar energy device. Still, they may regulate it on aspects such as approving only certain types of solar energy devices, providing maintenance, and requiring homeowners to apply for approval before installing solar panels.

Hazardous waste testing on solar panels in the marketplace has indicated that different varieties of solar panels have different metals present in the semiconductor and solder. Some of these metals, like lead and cadmium, are harmful to human health and the environment at high levels.

Are solar panels a hazardous waste under RCRA?
