The Department of Commerce (Commerce) is revoking,in part,the antidumping duty (AD) and countervailing duty (CVD) orders on crystalline silicon photovoltaic cells,whether or not assembled into modules (solar cells),from the People's Republic of China (China) with respect to certain off-grid...

Are crystalline photovoltaic cells countervailing duty?

On October 1,2024,the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determinations in the countervailing duty (CVD) investigations of crystalline photovoltaic cells whether or not assembled into modules (solar cells) from Cambodia, Malaysia, Thailand, and the Socialist Republic of Vietnam (Vietnam).

Are China's crystalline silicon photovoltaic products a countervailable subsidy?

Commerce also determined that imports of certain crystalline silicon photovoltaic products from China have received countervailable subsidies ranging from 27.64 percent to 49.79 percent.

Which crystalline silicon photovoltaic cells are excluded from the investigation?

Also excluded from the scope of this investigation are modules, laminates, and panels produced in Chinafrom crystalline silicon photovoltaic cells produced in Taiwan that are covered by an existing proceeding on such modules, laminates, and panels from China. Countervailing Duty Order, 77 FR 73017 (December 7,2012).

What products are covered by crystalline silicon photovoltaic cells?

The products covered by these investigations are crystalline silicon photovoltaic cells, and modules, laminates, and panels, consisting of crystalline silicon photovoltaic cells, whether or not partially or fully assembled into other products, including, but not limited to, modules, laminates, panels and building integrated materials.

Are crystalline silicon photovoltaic products dumping?

Commerce determined that imports of certain crystalline silicon photovoltaic products from China have been sold in the United States at dumping margins ranging from 26.71 percent to 165.04 percent.
